The application is for a proposed expansion to the existing Timberlane Campground, which is indicated to presently consist of 117 sites. The application and the plan indicate that the applicant proposes an additional 84 sites for a total of 201 campsites. The findings were that of 86 proposed campsites and 2 tent campsites. The applicant also proposes to construct an 1800 SF restroom/laundry building and three parking spaces.

 - More traffic on Timberlane; add trees to entrance area
 - Been there 42 year with no issues

- 6) Antonio Santos @ 363 Friendship
 - Trees down and never removed; will ruin neighborhood

- 7) Mike Grogan @ 137 Timberlane & Amelia Adams @ 141 Timberlane
 - No problems of campground
 - stormwater management plan?
 - Too much traffic now; campfires a concern & follow State guidelines
