- **Think Pavers Hardscaping, LLC (App. 2015-17)**
Block 1801, Lot 6 (C-Commercial District)
Use Variance/Site Plan Waiver

Representatives: Brian Lozuke, Esq, Tiffany CuvIELLO-PP, Jim Clancy-PE and Nicholas Fufari-applicant were sworn in.

The applicant proposes a landscaping/hardscaping commercial contractor business and future 14,000 square foot building to be located on the presently occupied “Lumberyard” site. The application primarily involves a use variance request only at this time.

(A) Will provide new fence

-Dumping at 6am & trucks always noisy

(A) If noise continues, contact zoning officer & applicant will no longer cause noise—applicant will talk to his employees

-Raymond Hiles @ 123 Kings Highway

-Has been parking in their lot for 37 years with permission from prior owner—only access to his property. Pavers not impervious.

(A) Pavers will be on pallets & will only take up a very small area on their 3 acres. Private property matter regarding parking—may provide access/applicant will work with him.

-Linda Moore @ 127/129 Kings Highway

-Part of applicant’s parking lot on her property & lighting spilling into houses at all hours and noisy

(A) No easements shown on their 2000 search; applicant will work with her
