Schedule A: Youth Sports Teams Clubs based in East Greenwich Township defined in Chapter 12.08.15 are exempt from the payment of any permit fees.

Schedule B: Youth recreation programs not included in Schedule A shall pay a \$250.00 fee for 8 weeks per season.

Schedule C: Non-profit Athletic Clubs and Groups not included in Schedule A or B shall pay a \$350.00 fee for 8 weeks per season.

Schedule D: For-Profit companies and trainers, etc. shall pay a \$500.00 fee for 8 weeks per season.

REFUNDS: All fees are nonrefundable if event is cancelled by applicant and is not rebooked by another party.

For all Categories, 50% payment of field usage fees, a written roster, and proof of insurance and hold harmless agreement must be submitted at the time of application to the issuing entity. For insurance, East Greenwich Township must be named as certificate holder with the Township address of 159 Democrat Road Mickleton, NJ 08056.

No permits will be issued unless these entire criterions are met.
